## First Supplement dated 3 April 2024 to the Euro Medium Term Note Programme Base Prospectus dated 2 November 2023



## HSBC Continental Europe €20,000,000,000 Euro Medium Term Note Programme

This first supplement (the **First Supplement**) is supplemental to, and should be read in conjunction with, the base prospectus dated 2 November 2023, which was granted the approval no. 23-457 on 2 November 2023 by the *Autorité des Marchés Financiers* (the **AMF**) (the **Base Prospectus**), which has been prepared by HSBC Continental Europe (the **Issuer**) with respect to its €20,000,000,000 Euro Medium Term Note Programme (the **Programme**).

The Base Prospectus constitutes a base prospectus in accordance with Article 8 of Regulation (EU) 2017/1129, as amended (the **Prospectus Regulation**).

Application has been made for approval of this First Supplement to the AMF in its capacity as competent authority pursuant to the Prospectus Regulation.

Unless the context otherwise requires, terms defined in the Base Prospectus shall have the same meanings when used in this First Supplement.

To the extent that there is any inconsistency between (i) any statement in this First Supplement and (ii) any statement in, or incorporated by reference in, the Base Prospectus, the statement referred to in (i) above will prevail.

This First Supplement has been prepared pursuant to Article 23.1 of the Prospectus Regulation, for the purposes of giving information which amends or is additional to the information already contained in the Base Prospectus.

This First Supplement has been prepared for the purposes of:

- 1. updating the "Risk Factors Relating to the Issuer" section;
- 2. incorporating by reference the HSBC Continental Europe's 2023 Universal Registration Document and the 2023 *Document d'Enregistrement Universel* (each as defined on page 5 below) and inserting a related cross-reference table in the "Documents Incorporated by Reference" section of the Base Prospectus;
- 3. incorporating by reference the HSBC Continental Europe Capital and Risk Management Pillar 3 Disclosures (as defined on page 5 below) and inserting a related cross-reference table in the "Documents Incorporated by Reference" section of the Base Prospectus; and
- 4. updating sections 3, 4, 6 and 13 of the "General Information" section of the Base Prospectus.

In accordance with Article 23.2 of the Prospectus Regulation, in the case of an offer of Notes to the public, investors who have already agreed to purchase or subscribe for Notes issued under the Programme before this First Supplement is published have the right, exercisable before the end of the period of two working days

beginning with the working day after the date of publication of this First Supplement to withdraw their acceptances. This right to withdraw shall expire by close of business on 5 April 2024.
