HG.1.1	OC Calculation: Actual	<p>Nominal Overcollateralisation "OC" ratio</p> <p>The OC ratio as established to comply with contractual and rating agencies minimum requirements is a nominal rate calculated by dividing the nominal outstanding amount of eligible assets (substitute assets and accrued interests excluded) by the nominal amount of covered bonds (after taking into account if any interest rate or currency swaps and accrued interests excluded).</p> <p>The over-collateralization is calculated as the ratio between the total outstanding balance of pledged home loans (excluding accrued interests) and the nominal of covered bonds. HSBC SFH holds no interest rate swap at reporting date.</p> <p>The legislation requires that the calculation of the legal coverage ratio be audited semi-annually within a period of three months following the calculation date. As a consequence, the current ratio is provisionnal / unaudited when the report is published.</p> <p>The last audited ratio is based on 31st December 2015 cut-off.</p> <p>Rating agencies : Minimum OC</p> <p>The highest minimum OC requirement to maintain the highest rating is at 11.2% based on the last published performance / rating reviews.</p>
